MHEREAS. Article IX, paragraph B. of the Kaster Deed provides a mechanism whereby the Hembers of the Council of Co-country may amend the said Bylava by affirmative vote of the Co-country country two-thirds of the value of the property as set forth in the Master Deed; and

WHIREAS, The Council of Co-owners, by vote of the membership at its annual meeting held September II, 1982, and upon proper notice given, did spend the said Bylava ax set forth herein; and

WHEREAS, Arcicle IX, paragraph C of the Master Daed provides that the said amendments shall be made of record by execution and recording of and written addendum to the Master Deed of which the Bylaws are a part;

SOW THEREFORE, BE IT KNOWN TO A'L. HEN BY THESE TRESENTS that the Bylave of the Master Daed to Mariner's Vatch Villas Horizontal Property Regime as recorded in the R.M.C. Office of Charleston County, S.C. in Book P124, page 95, have been amended by the Regime, by a vote of the membership of the Council of Co-owners at the annual meeting held on September 11, 1982, at 9:30 a.m. in Club Conference Room A on Kinvah Island, South Carolina. Notice of the meeting, together with notice of the proposed amendment to the Bylave to be neted upon at the said meeting, was given to each Hambar of the Council of Co-owners by certified mail more than thirty days prior to the date of the meeting as provided for in Article I, Section D of the Bylave of the Regime.

The total moder of votes necessarily cast in favor of the proposed assendment to the Bylava to adopt the said assendment was votes representing two-thirds of the value of the Property as set forth in the Mauter Bood. The following amendment to the Bylava was unanimously approved by affirmative votes of all those owners propose, all proxima held sy such persons being cast in favor of said Amendment, and all other proxy vatua being cast in favor thereof pursuant to Article I, Sections C and D of the Bylava; the sum of which represented the ament and affirmative vote approving the arendment of Co-overs owning one hundred persons of the Property.
